The purposes for which the corporation is organized are to take, receive, acquire, own, and hold the Life Membership estate, funds, principal, income, monies, accounts, grants, donations, gifts, and properties, both real and personal, tangible and intangible, for such uses and purposes and with such powers, and obligations as are outlined in the Charter and corporate bylaws.
